For **Standard Connection Applications**, fees are due at the following times:

- **Pre-Assessment:** Standard Connection Assessment is payable prior to the application being assessed.
- **Pre-Construction:** After assessment is complete, the total cost of all fees and charges will be provided and must be received before construction commences.

These fees and charges will include:

- Standard Connection Certification **or** Standard Connection Construction, and
- Infrastructure charges (if applicable).

Urban Utilities reserves the right to provide customers with a partial refund only, of service fees associated with their application. This right will be exercised at Urban Utilities' sole discretion. In determining whether to refund any service fees, Urban Utilities will consider factors such as if work has commenced, whether the work or the connection is unable to be completed, the costs incurred by Urban Utilities and the amount of work performed (such as where separately priced service items are involved). Inability to complete may be due to site constraints including, but not limited to: physical obstructions, environmental constraints, site or ground conditions, safety risks, legislative or regulatory restrictions including protected vegetation.
