# 1. Building Over Asset (BOA), Construction Over Asset (COA) and Form 32 processes are now in the Portal

Hark! The dawn of a new era upon us, where our method of communication hath evolved. No longer doth thou need to dispatch missives through the ether; behold, our BOA, COA and Form 32 processes hath embraced the digital realm, now accessible with but a click.

Farewell, ye days of cumbersome emails! Henceforth, our correspondence shall flow as swiftly as the coursing river, through the conduit of the online domain.

#### How Arthur Weier, Senior Technical Assessment Officer, may interpret the above:

Hey! The time has arrived to change the way you lodge applications/requests for BOAs, COAs and Form 32s. We've brought these processes into the 21st century and you can now find them all as part of our expanding services in the Developer Services Portal (the Portal). No more emailing us as all correspondence is now via the Portal.

## 2. Hark, dear patrons, lend thy ears apace, for I bring forth a NEW FORM, a novel grace!

#### And to be clear, what we really want you to know is:

Please use the new <u>Access Consent Form!</u> The name suggests how this form should be used. It is <u>now required</u> for all developments where land is directly impacted by your development plans and Water Approval lodgement permission and/or site access is needed to complete works.

Speaking of forms, as of 1 March 2024, we <u>will only be accepting the updated</u>

January 2024 version of the Property Owner/s Consent Form.

Don't get stuck in ye olden days! Ensure thou shalt forever be up-to-date with thy approved products.

#### As Michael McCann, Senior Technical Advisor, would say:

Make sure you're using the <u>Infrastructure Products and Material List</u> (lasted updated November 2023). You can check the SEQ Code website as the <u>IPAM list</u> is revised regularly or stay up-to-date by <u>registering your interest in being advised of changes</u> to the SEQ Code.

Remember - the IPAM list should be read holistically. Unapproved tapping band fittings are incorrectly being used. Line Items 704-711 of the IPAM list relate to the products for *Tapping Bands for DI & PVC Pipes*. However, reading further into the line items we can see they are also approved for <u>AC and PVC</u> pipes in some instances. Taking into consideration the specified requirements and actual product types approved, it can be determined that only positive stop tapping bands are approved for use on the applicable pipe types.



The following are not suitable as they can continue being tightened and have no tolerance limit.

Take heed, for this task rests solely upon thy shoulders; let it not escape thy memory, lest complications arise.

#### Nicole Johnson, Head of Developer Services, says:

EVERY TIME you create a new application in the DS Portal, you MUST ADD YOUR WORK ADDRESS as it is not auto populated by the digital system. Why is an address needed in a digital system? The Portal pulls this information when creating a charge notice - otherwise nonsensical words appear and we need to manually update it, increasing the risk of further errors. Thanks in advance!
