(Consent) The issue of a smartcard constitutes Urban Utilities' consent to the applicant's taking of water from Urban Utilities' water filling stations ("Consent"). Urban Utilities may, without liability to the applicant, suspend or terminate the Consent (together with any smartcards issued to the applicant), at any time and for any reason. 2. (Excluded Activity) The Consent does not permit the taking of water from Urban
Trading as				Utilities' infrastructure via hydrant standpipes. A separate consent is required from Urban Utilities' to allow such taking of water. 3. (Technical Requirements) Smartcard filling station outlets are fitted with both 50mm and 75mm male Camlock fittings. Tankers/vessels filled from a 50mm or 75mm outlet must be fixed at both ends during filling. 4. (Insurance) The applicant must effect and maintain public liability insurance of at least \$20 million per occurrence at all times while the Consent is operative. If requested by Urban Utilities, the applicant must promptly provide evidence of its insurances

(Risk) All risk and title in water taken from a water filling station transfers to the applicant at the time water is taken from the filling station outlet. The applicant is solely responsible for ensuring water is taken and used in accordance with all applicable laws.
